## Directions for use

- Antiseptic Bath Before Surgery: Take a shower three times before surgery:

1. Two days before surgery
2. Day before surgery
3. Morning of surgery

With each shower, firstly wash your hair with normal shampoo and rinse your entire body thoroughly to remove the residue. Then, apply product to your entire body from the neck down using a clean washcloth or your hands for 5 minutes and then rinse entire body.

- Daily bath for ICU patients: Nurse can apply product using clean washcloth to wash patients body.

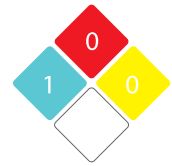
